This memorandum of understanding is made and executed on 28/12/22 for 05 years from 28/12/22 to 27/12/27 between the Nalbari college, P.O. Nalbari, Dist. Nalbari, Assam, India, PIN - 781335 and the Nalbari Sports Association, Nalbari, Assam, India, PIN - 781335.

Preamble

Nalbari College, Nalbari is one of the premier higher educational institutions in Assam. The institution is established in pre-independent India on 4th July 1945. From its establishment onwards, the college has taken a pioneering role in shaping and promoting higher education in the entire lower Brahmaputra valley. This is one of the premier colleges that consistently demonstrated excellence in academic and research pursuits.

The Nalbari Sports Association (NSA) is a prominent organization in Nalbari, Assam, dedicated to promoting sports and athletic activities in the region. NSA organize various events and tournaments to encourage participation and improve the local sports infrastructure. Apart from Football, Hockey, Cricket, Kabadi, Badminton and Carrom; NSA also hosts significant athletic events, such as the Inter District Sub-junior, Junior, and Senior Athletics Championship. This event attracts around 1,000 athletes from across the state, emphasizing the NSA's commitment to broad-based sports development

Nalbari College, Nalbari and Nalbari Sports Association, Nalbari have joined forces to promote sports activities among the students of Nalbari College. This collaborative effort aims to enhance the physical fitness and sports skills of the students, encouraging greater participation in various sports disciplines and fostering a culture of athletic excellence in the college community.

Nalbari College, Nalbari, and Nalbari Sports Association, Nalbari hereinafter collectively referred to as the parties/institutions, and individually as party/institution.

Objectives:

The objective of the Memorandum of Understanding (MoU) between Nalbari College and Nalbari Sports Association focuses on the following objectives:

1. To jointly develop and maintain sports facilities at Nalbari College for the benefit of students and the local community.
2. To design and implement comprehensive physical education and sports programs for students.
3. To identify talented athletes within the college and the community and provide them with specialized training and development opportunities

There will be no financial obligations on both parties under this agreement.

Each party shall designate an administrative office/department to oversee and facilitate the implementation of any agreements arising out of this MoU.

Intellectual Property Rights:

Nalbari College, Nalbari and Nalbari Sports Association, Nalbari agree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions, and patents generated during the MoU shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.

Dispute Settlement:

In the event of any dispute or differences arising under this agreement, the parties shall try to discuss and arrive at an amicable resolution thereof. If the parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed under the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The parties agree that the decision of the arbitrator shall be final and binding on the parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

This MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create a legal relationship between the parties.

This MoU shall come into force from the date of its signatures and shall remain valid for 05 years.

This MoU may be modified/ renewed, or extended with the mutual written consent of the parties.
