This memorandum of understanding is made and executed on 27-04-23 for 05 years from 27-04-23... to 26-04-28... between the Nalbari College, Nalbari, P.O. Nalbari, Dist. Nalbari, Assam, India, PIN - 781335 and the Sarathi Multi Speciality Hospital, Nalbari, Assam, India, PIN - 781335.

Preamble

Nalbari College, Nalbari is one of the premier higher educational institutions in Assam. The institution is established in pre-independent India on 4th July 1945. From its establishment onwards, the college has taken a pioneering role in shaping and promoting higher education in the entire lower Brahmaputra valley. This is one of the premier colleges that consistently demonstrated excellence in academic and research pursuits.

Sarathi Multi Speciality Hospital, located in Nalbari, is a leading healthcare institution in the region. The hospital plays a crucial role in providing comprehensive medical care through its multi-specialty services. Sarathi Multi Speciality Hospital continues to be a pillar of healthcare in Nalbari, providing critical services that significantly contribute to the health and well-being of the community.

Both parties have been working on applied research in life science and health care. The Nalbari College, Nalbari and Sarathi Multi Speciality Hospital, Nalbari would be mutually supportive in the clinical diagnostic based research work.

Nalbari College, Nalbari and Sarathi Multi Speciality Hospital, Nalbari, hereinafter collectively referred to as the parties/institutions, and individually as party/institution.

Objectives

- 1. Incorporate practical, hands-on training for life science students in clinical diagnostic techniques and laboratory procedures.
- 2. Collaborate on updating and enhancing the curriculum to include contemporary diagnostic methodologies and technologies.
- 3. Facilitate internship programs for life science students at the clinical diagnostic laboratory to gain practical experience and industry exposure.
- 4. Offer training sessions, workshops, and seminars by laboratory professionals to students and faculty to keep them abreast of the latest advancements in clinical diagnostics.

There will be no financial obligations on both parties under this agreement.

General Coordinators:

Each party shall designate an administrative office/department to oversee and facilitate the implementation of any agreements arising out of this MoU.

Intellectual Property Rights:

Nalbari College, Nalbari and Sarathi Multi Speciality Hospital, Nalbariagree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions, and patents generated during the MoU shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.

Dispute Settlement:

In the event of any dispute or differences arising under this agreement, the parties shall try to discuss and arrive at an amicable resolution thereof. If the parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed under the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The parties agree that the decision of the arbitrator shall be final and binding on the parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

This MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create a legal relationship between the parties.

This MoU shall come into force from the date of its signatures and shall remain valid for 05 years. This MoU may be modified/ renewed, or extended with the mutual written consent of the parties.
