Through The Lens of Time....

Nalbari College is one of the premier colleges of Assam. Established way back in pre-independent era (**on 4th July, 1945**), this college has taken a pioneering role in shaping and promoting higher education in the entire lower Brahmaputra valley. In the beginning, the college was affiliated to the Calcutta University, but in 1948, when Gauhati University was established, it came under the academic jurisdiction of the latter. The college received the UGC recognition under Section 2(f) in 1962. Beginning with a modest number of only 28 students, today it has a sizable strength of about 4450 students (including Higher Secondary programme). Spreading over 16 acres of land, the college has a built up area of approximately 8 acres.

Nalbari College is a multi-streamed co-educational institution imparting education right from Higher Secondary to PG level. At present it offers UG programmes for 09 Humanities & Social Science departments and 07 Science departments and PG programme for Assamese and English. Further, since 2013, the College with approval from the University has introduced two more professional courses i.e. Bachelor of Physical Education (B.P.E) and Bachelor of Science in Information Technology (B.Sc. IT) on regular basis. Nalbari College is the first college to start B.P.E in entire Assam. Besides, the college has two other self financing courses i.e. Bachelor of Computer Application (BCA) and Post Graduate Diploma in Computer Application (PGDCA). Further the College is offering 19 Add-On Courses for its students.

In order to facilitate those students who cannot pursue regular education the college offers distance learning facilities through its affiliating centres of Center for Distance & Online Education under Gauhati University, Krishna Kanta Handique State Open University and Assam State Open School.

The College has introduced Four-Year under graduate programme (FYUGP) already. The detail of the programme has been mentioned in subsequence pages of the Prospectus.

Our Strengths:

Four-Year under Graduate Degree Programme (FYUGP)

The Four-Year Undergraduate Programme (FYUGP) is based on the National Education Policy (NEP) 2020. The policy recognizes that higher education plays an extremely important role in promoting human as well as social well-being. The policy also endeavours developing India as envisioned in its Constitution – a democratic, just, socially conscious, cultured, and humane nation upholding liberty, equality, fraternity, and justice for all. NEP 2020 notes that “given the 21st-century requirements, quality higher education must aim to develop good, thoughtful, well-rounded, and creative individuals”.

The FYUGP is designed to cater to the diverse academic needs of the student and seeks to offer options of multiple entries / exits and obtain a Certificate or a Diploma or Degree with or without Major or a Degree (Honours) with Research at various levels as stipulated under the policy.

Objectives

The aims and objectives of the FYUGP under NEP 2020 are to highlight certain fundamental principles that would guide both the education system at large, as well as individual educational institutions. These objectives have a direct bearing on the curricula for different levels of higher education:

Programme and curricular components

Overview and structure

The complete FYUGP consists of 8 semesters, to be completed in a minimum of 4 academic years. Each academic year has two semesters. Each semester has a maximum credit allocation of 22. The credit requirements for GU's FYUGP is as follows

- (a) Semester I : 22
- (b) Semester II : 22
- (c) Semester III : 22
- (d) Semester IV : 22
- (e) Semester V : 22
- (f) Semester VI : 22
- (g) Semester VII : 22
- (h) Semester VIII : 22
- (i) Total : 176

Course-wise credit requirements

Below, we provide the minimum credit requirement for various course along with a mention of their semesters (as prescribed by the UGC).

(a) Core Course

- a) First Major : 60 (Semesters 1-6)
- b) Minor : 12 (Semesters 1-6)
- c) Second Major (Double Major) : 48 (Semesters 1-6)

(b) Common Course

- a) Multidisciplinary : 9 (Semesters 1-3)
- b) Skill Enhancement Course (SEC) : 9 (Semesters 1-3)
- c) Valued Added Course (VAC) : 6 (Semesters 1, 2, 4)
- d) Ability Enhancement Course (AEC) : 8 (Semesters 1-2, 5-6)
- e) Internship : 4 (in any Semester from 3-6)
- f) Research Methodology : 4 (in any Semester in 5 or 7)

(c) For Honours and Honours with Research

- a) Advanced Core, Dissertation : 40 (Semesters 7, 8)

• Open Core Credits

From fourth to sixth semester, one will have time for 4 optional open core credits per semester, which one can utilise to study either of the Major or two Minors. They can also come handy, if one had changed a Minor subject in between.

• Double Major

If a student is ready to do some more hard work, he/she can take some extra online courses (from designated sources only) related to the Minors and can then convert one of the Minors to a second Major by the time one completes 3 / 4 years of study. This is over and above the first Major. In this case, one will have a Bachelor's Degree with Double Major.

FYUGP degrees & course structures

The FYUGP at GU is designed to offer two types of Bachelor's Degrees to the students at the end of the successful completion of the programme —

- (i) Bachelor's Degree in a Stream and
- (ii) Bachelor's Degree in a Discipline.

Curricular components

The entire FYUGP curriculum is divided into two parts – (a) Core Courses and (b) Common Courses, which are described below.

Core courses

The core course determine the ultimate degree, diploma or certificate a student will earn at the end of third (or 4th) year, 2nd Year or 1st Year respectively. A student needs to study at least 3 core subjects. In case of a bachelors degree in a stream the components of the core courses are major and minor or minors while bachelors degree in a discipline there are no major and minor. Usually, a student will choose one Major subject and two Minor subjects in case of degree in a stream. All core courses have a credit allocation of 4. All together, irrespective of any Major or Minor options, a student will necessarily need to study 21 courses with total credit allocation of 84 over a 3-year programme.

Major Course The minimum credit requirements for a Major Course over a 3-year period are 60 which translate to 15 courses (papers).

Minor Course The minimum credit requirements for a Minor Course over a 3-year period are 12 which translate to 3 courses (papers).

Common courses

As the name suggests, these courses will have to be studied by all students of FYUGP. Together the common courses have a credit allocation of 36 divided over five subdivisions. They are

- (a) Multidisciplinary Courses : Total Credits 9
- (b) Ability Enhancement Courses (AEC) : Total Credits 8
- (c) Skill Enhancement Courses (SEC) : Total Credits 9
- (d) Value Added Courses (VAC) : Total Credits 6
- (e) Internship : Credit 4

A brief description of these courses is given below.

(A) Multi-disciplinary Courses

These are 3-credit courses spanning over five different groups of subjects — (i) Natural and Physics Science, (ii) Mathematics, Statistics, and Computer Applications, (iii) Library, Information, and Media Sciences, (iv) Commerce and Management, and (v) Humanities and Social Sciences. The level of these courses is of Class XII.

Each student needs to take at any three courses, each with 3-credits from these five sub-groups during Semesters 1-3.

(Key Points: A student CANNOT choose a multidisciplinary subject, if he/she has already studied that subject during Class XI-XII. Also the subject of these courses MUST not be among the Core Subjects the student has already chosen.)

(B) Ability Enhancement Courses (AEC)

This is a 8-credit course covering Modern Indian Languages (MIL) and English Usage (Communication).

Each student needs to complete two courses of 4-credits each – one from English Usage and other from the group of MIL, especially designed for this purpose. Both these courses are split into 2-credit parts each. The **English Communication course is to be completed during the 1st and 2nd Semesters** and the **MIL course is to be completed during 5th and 6th Semesters**.

(C) Skill Enhancement Courses (SEC)

These are various skill courses with total credit allocation of 9. All students need to complete three Skill Courses, each with 3 credits, in Semesters 1, 2, & 3.

(D) Value Added Courses (VAC)

The VAC courses will come from four sub groups — (i) Understanding India, (ii) Environmental Science, (iii) Digital and Technological Solutions, and (iv) Health & Wellness, Yoga Education, Sports, and Fitness. All together they will have a credit allocation of 6.

Each student will have to take any three courses, each of 2-credits, from any three groups during Semesters 1, 3, & 4. Here one course from the **Environmental Science** group is *compulsory* except if the student takes a core course on Environmental Science.

(E) Internship

All students are to carry out an Internship with a credit allocation of 4. The internship can be carried out in any semester during Semesters 3-6. As internships are meant to be done during semester breaks, they will *not* interfere with other classes.

Progression and exits

The progression and exits during the whole course structure is given below.

(a) After 1 Year

One can exit just after one-year. In this case, the student will have to complete one extra Vocational / Skill course (Exit Course) of 4 credits and can exit the programme. The student will get a **Certificate**. The minimum total credit requirements are 44 (and 4 credits extra for the exit Vocational course).

(b) After 2 Years

One can exit the programme after two-year course as well. In this case, the student will have to complete one extra Vocational / Skill course of 4 credits and can exit the programme. The student will get a **Diploma**. The minimum total credit requirements are 88 (and 4 credits extra for the exit Vocational course).

(c) After 3 Years

If a student completes 3 years, he/she can exit the programme. In this case the student will get a **Bachelor's Degree**. The minimum total credit requirements are 120.

(d) After 4 Years

After completion of 4 years, the student gets either a **Bachelor's Degree (Honours)** or a **Bachelor's Degree (Honours) with Research**. The minimum total credit requirements are 160.

A Student seeking admission for the session 2024-25 should apply as per NEP-2020 on Four Year Undergraduate Programme (FYUGP) of Gauhati University through the **SAMARTH e-Gov** portal (<https://assamadmission.samarth.ac.in>). The date for submission of Application Form, and Admission are to be notified in the College Notice Board as well as in the College Website (www.nalbaricollege.ac.in).

In addition to SAMARTH e-Gov Portal candidates must register their name in the college admission portal (nalbaricollege.co.in/)

Seats are reserved for students belonging to SC/ST(P)/ST(H)/OBC-MOBC categories as per State Government rules.

There are also provisions of seats for students having proficiency in co-curricular activities.

Original copies of certificates of proficiency in co-curricular activities and SC/ST/OBC-MOBC/BPL certificates should be uploaded/ produced at the time of admission.

The students selected must get themselves admitted within the stipulated time as mentioned in the website.

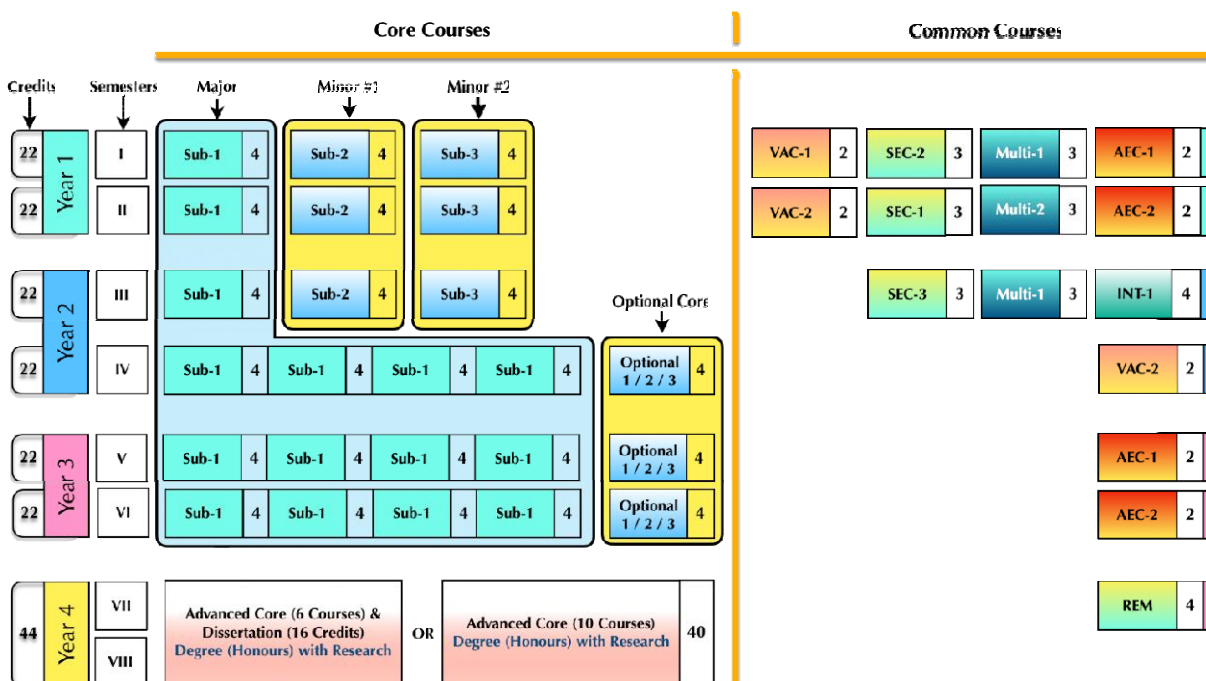

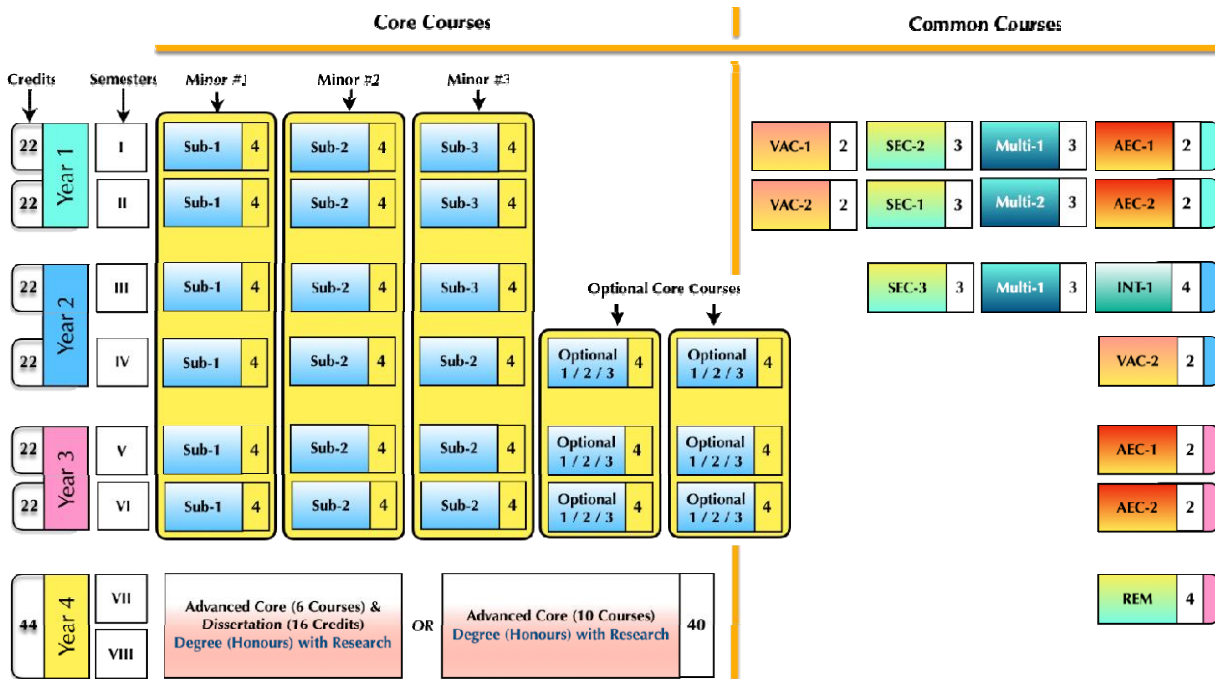

Examples

Here, we are providing two options a student can have. All the examples given below are for a 3-year degree programme.

Example 1 – Degree with Major and Minors

In this example, we show the subject distribution for a Bachelor Degree in Arts with Major and two Minors. As one can see, there are 12 **Open Core Credits** to be earned by a student above the minimum requirement of 120 credits. This open core can be utilized for any of the following:

- For another Minor
- For one of the Minor so that it can be converted to a Double Major
- To complete course from the fourth year

In the figure below, the distribution is shown visually. The papers marked in **bold-red** denote that they are compulsory. One should note that the Internship can be done in any semester within the 3rd and the 6th. As an internship is always done during a break, it essentially *does not* interfere with the semester classes.

General Library Rules:

Before entering the library, books (not belonging to the Library), all sorts of bags, umbrellas, packets etc. are to be deposited in the property counter.

A member will have to show the Membership Card/Identity Card/Gate Pass at the entrance whenever he/she wants to enter the Library.

Before entering the Library the Gate Register is to be signed legibly.

Books treated as 'Reference' and 'Rare' are not issued on loan. Journals and periodicals will not be issued. Books on loan with members can be recalled by the Librarian at any time.

Borrowers must satisfy themselves about the physical condition of the book before borrowing, otherwise they will be held responsible for any damage or mutilation noticed at the time of returning.

An overdue charge of Re 1. for a book per day shall be levied on a member, if a book is kept beyond the period of loan. The period of loan can be extended by the Librarian, on individual cases. The overdue fines may be reduced or waived by the Librarian on very special cases only.

If a borrower fails to return a book borrowed by him/her or if the book is found to be damaged or mutilated he/she will be required to either (a) replace the book with a new copy or (b) pay Ten times on the publisher's price of the book.

While borrowing book/s, a student member must produce his/her Identity Card at the Issue Counter. The Membership Card is not transferable.

Overwriting on the Membership Card is not permissible.

In no case the expiry date of student Membership Card shall be extended.

If the Membership Card gets lost or mutilated because of use or otherwise, it should be reported to the Librarian immediately. A duplicate Membership Card will on prayer be issued on payment. The member, however, will continue to be responsible for any loss which the Library may suffer through the loss or misuse of the Card.

Students are to return books within two week time immediately after their final examination is over, failing which they will be declared library defaulter.

Students of science classes are to return books within three days after their practical examination are over, failing which they will be declared library defaulter.

Teachers, officers and employees of the College shall have to take Library Clearance Certificate before they take release from this College to join other institution or get retired from this College.

Examination and Attendance:

In case of H.S. course, a student must pass the first year examination for promotion to the second year class. The result of first year examinations is declared by the College and that H.S. Final Examination declared by Council.

The Sessional/Preparatory Examinations are conducted by the College. As per Gauhati University guideline, the marks of Internal Assessment would include marks of sessional examination, attendance of the student and home assignment/seminar presentation. Attendance in all examination of the College (Sessional/unit test/preparatory) are mandatory. Students failing to appear in any College exams for some unavoidable circumstances are to inform the College authority immediately and are to sit in specially arranged exams notified by the Examination Board of the College.

Students having less than 75% attendance of the classes taught in a academic year shall be declared as Non-Collegiate and Will be debarred from contesting college election.

Will be allowed to sit for the examination only on payment of a fine.

Students having less than 60% of attendance will be declared as dis-collegiate and will be debarred from appearing in the examinations.

Identity Card:

A non-transferable identity card with bar code is issued to each student in the beginning of every academic session. All the students shall wear their identity cards, well displayed. Any teaching or non teaching staff shall have the right to verify it. Duplicate identity card is issued in case of loss or damage of the original card, on payment of identity Card fee. Students' Code of Conduct and Disciplinary Processes

Nalbari College, Nalbari stresses in maintaining a healthy social and educational atmosphere in its campus. Students are expected to be honest in their behavior and responsible towards the society. While enjoying individual freedom they must not hamper freedom of others. In this regard the Code and Conduct for Student's outlines student conduct and disciplinary policies that pertain to students and student organizations at Nalbari College. It is designed to provide information to students, faculty and staff regarding the ideals that underlie our academic mission, and the expectations that the Institute nurture regarding the conduct of students.

The following considerations constitute the code of student conduct for Nalbari College, Nalbari:

Any student, individually or as a member of a group involved in any unacceptable social behavior on or off campus shall be subject to disciplinary actions by the Students' Code of Conduct Committee.

Students having less than **75% attendance** of the classes taught in a academic year shall be declared as Non-Collegiate and Will be debarred from contesting college election.

Will be allowed to sit for the examination only on payment of a fine.

Students having less than 60% of attendance will be declared as Dis-collegiate and will be debarred from appearing in the examinations.

A student who is absent for 15 consecutive days in the beginning of the academic session will automatically forfeit his/her seat.

The courses of studies in Nalbari College are full-time courses. No student shall take any other full-time course simultaneously.

Harassing juniors, ill treatment to other fellow students or ragging in any form is objectionable and liable to be treated as criminal offence by the law enforcing agencies as per the directives of Honourable Supreme Court of India.

All the students are expected to attend all college functions in college uniform unless otherwise specified. Any dress code violation noticed within the campus will attract a fine of Rs.300 and could initiate further disciplinary actions.

All the students shall wear their identity cards, well displayed. Any teaching or non teaching staff shall have the right to verify it.

Careful handling of the furniture, equipments, fixtures and appliances of the College is a must. In the event of any misuse/careless handling/damage of property, the responsible students will have to bear the cost of replacement/repair with fine.

Political activity in any form by students and Students' Organizations are strictly prohibited in the College campus. Unauthorized meetings, propaganda work, celebrations, decorations, processions or fund collections are forbidden within the College, in hostels, and even outside the College campus.

Misbehavior or disrespect towards girl students, use of threat or violence against members of the teaching and non- teaching staff or fellow students will be considered as very serious cases of misconduct.

Students must not loiter in the corridors and in front of the class rooms and keep quiet as much as possible during College hours.

Use of mobile phone and other electronic gadgets inside classroom will fall under the breach of discipline. Mobile phones are not allowed inside examination hall.

Chewing of tobacco and spitting will amount to a fine of **Rs. 1000/** without fail and may cause expulsion from the College.
